#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 10 days during a 30 day period beginning on November 13, 2014. The average flaring volume was 79.8 MCF/D; volumes were measured daily. A pipeline connection was established November 19, 2014 and gas has been flowing to sales. Frequency of flaring decreased as the flowback and maintenance phase of the well was completed.

There is a presence of H2S; sampling showed 0.50ppm.
