This APD will either require modifying the BHL which would require new Well Location Plat, Deviated Drilling Plan and Directional Data (15 attachments) or Waivers from mineral owners and an Exception Location Letter (10+ attachments). Consultation with COGCC staff and the operator have resulted in concurrence that this APD should be rejected.

8	Emissions mitigation	<p>Green Completions - Emission Control System: Test separators and associated flow lines and sand traps shall be installed to accommodate green completions techniques pursuant to COGCC Rules. In the anticipated absence of a viable gas sales line, the flowback gas shall be thermally oxidized in an emissions control device (ECD), which will be installed and kept in operable condition for at least the first 90-days of production pursuant to CDPHE rules.
