Request waiver for COA for Open Hole Log requirement on the Walton 25-D Pad, as on OH Density Neutron Induction log (COGCC Doc #2514346) from the Bears 4-30 well (API 05-123-34218) is on file. Such well is located ~930' NE of the subject well. The Bears 4-30 OH log is representative of the stratigraphy for all wells to be drilled on the Walton 25-D pad. In addition, GR/CBL logs will be run as part of the completion process for all wells drilled on the pad. A map showing the location of the Bears 4-30 well in relationship to the subject well and pad is attached. There are also a number of other wells along the lateral of the subject well from which the stratigraphy can be identified.
