Description of Alleged Violation:  
Operators submitting Applications for Permit to Drill (APDs) for oil and gas wells submitted on or after May 1, 2013 are required to either:  
" Collect groundwater samples and submit the analytical results to the COGCC within 90 days, or  
" If a sample cannot be obtained, submit a Sundry Notice requesting an exception to Rule 609 prior to setting conductor pipe (Rule 609.d.(1).  
The well cited above was spud on 03/31/2015 and did not meet either of these requirements.

Act, Order, Regulation, Permit Conditions Cited:  
RULE 609

Abatement or Corrective Action Required to be Performed by Operator:\*  
Either collect post drilling samples as described in Rule 609 or if samples may not be obtained submit a Sundry Notice seeking relief from the 609 requirements. Any Sundry seeking relief must include details of the operator's good faith efforts to obtain groundwater samples.
