At the request of Extraction Oil and Gas, and following the DJ Horizontal Offset Policy, Option 1, KPK will perform an annular fill to provide cement coverage over the aquifers down to 800'. Coverage over the Niobrara is already in place and verified with CBL attached to this form. TOC is 6470' and top of the Niobrara is at 6790'.

KPK will run a 1" tubing to 800' and pump 150 sacks of Class G cement, which will be later verified with a CBL.
