COMMENTS:

WPX Energy respectfully requests permission from COGCC to utilize the Mautz Ranch multi-well pit beyond the August 30, 2015 pit permit expiration date for an additional 6 months to February 29, 2016. This multi-well pit was put into service on August 30, 2012 and was permitted for recycling of produced water in order to support completion operations. Extending the pit expiration date to February 29, 2016 would allow WPX Energy to finalize and submit the Form 28 application to permit a long term use of the pit. The Mautz Ranch multi-well pit construction and liner system meets the COGCC 904 b. and 904 d. requirements for a long-term water recycling pit and consists of:

- One BentoLiner NSL geosynthetic bentonite liner
- One 40 mil HDPE liner
- One 200 mil Hypernet Geonet Drain Mat
- One 60 mil HDPE liners
- Leak detection system
- Permanent down joints for water loading
- Permanent exclusionary netting and fencing

The pit liner system was designed and installed in accordance with manufacturer's specifications. Pit liner installation report was submitted to COGCC via Form 4 (Doc # 2157029).

To ensure compliance with the COGCC 900 Series regulations, the pit is inspected for the following parameters:

- Freeboard
- Sheen
- Hydrocarbon accumulation on the liner
- Liner anchor trench
- Liner integrity
- Netting and fencing
- Berm around the location
- General housekeeping
- Leak detection system
