Neighborhood Meeting Summary
Extraction Oil & Gas, LLC, Operator
Bybee 14-K Pad
Johnson Trust 13-I Pad
Weld County, Colorado

Pursuant to Town of Frederick Municipal Code, Extraction Oil & Gas, LLC (Extraction), as operator, held a Neighborhood Meeting for the Bybee 14-K and Johnson Trust 13-I Pads on Wednesday, January 28, 2015, from 6:00pm to 7:00 pm at the Frederick Town Hall located at 401 Locust Street, Frederick, Colorado.

In attendance were eight Extraction representatives, including Matt Owens, President; Chris Kennedy and Mohammed Said from the Town of Frederick; Marc Morton from the Colorado Oil and Gas Conservation Commission (COGCC); Chris McGowne from the Colorado Oil and Gas Association (COGA); seven property owners noticed pursuant to Town of Frederick Municipal Code.

Attached please find a copy of the sign-in sheet, meeting notice, and Location Drawing and Notification Zone Drawing used as presentation materials.

The meeting began with presentation of the project by Matt Owens, President, and Jamison McIlvain, Landman for Extraction. Building setbacks, and noise and light mitigation, ground water sampling and air quality measures were discussed.

Marc Morton/COGCC discussed the State's rules regarding safety setbacks and local government outreach.

The floor was opened for questions from property owners. One major question from property owners was in regard to their property values. Chris McGowne/COGA addressed this issue by referring to a Weld County report that states property values have not been affected by oil and gas drilling; in fact, Weld County has shown an increase in economic growth.

Another major question from property owners was in regard to the site's proximity to their homes and why the site could not be moved south. Extraction's drilling and operations engineers and landman explained why this was the only option for site location, due to drilling design and negotiated surface use agreement with surface owner. Extraction resolved property owners' concerns over sound, light and visual issues by offering the following mitigation measures: operator will use quieter rigs, perform baseline noise monitoring and testing, investigate the use of electricity versus diesel fuel, employ the use of sound walls to shield sensitive areas near homes, and negotiate landscape screening with their HOA. For the record, Extraction suggested property owners visit one of their sites in Windsor to see the completed landscaped site.




