Noble respectfully requests to amend the casing program in this well. This sundry is in order to comply with COA #5 on the approved permit (Doc #400789038). Please rescind COA #2 on the approved permit, as the revised casing and cementing program shows adequate protection of all aquifers. Noble Energy shall isolate the Upper Pierre Aquifer from the Fox Hills Aquifer with surface casing and cement and utilize intermediate casing and cement to ensure isolation from below.
