Comments:

The reclaimed well pad was seeded with Anadarko Dryland Pasture Mix. This mix consists of Tetraploid Perennial Ryegrass (19.68%), Smooth Brome, Lincoln (18.66%), Intermediate Wheatgrass, Oahe (14.76%), Dahurain Wildrye (14.44%), Orchardgrass, Paiute (14.29%), and Pubescent Wheatgrass Luna (13.35%). A step-point vegetation survey was conducted across the undisturbed reference area as well as reclaimed site. 100 survey points were recorded within the reclaimed disturbance and 100 survey points within the reference area, representative of pre-disturbance vegetation. Vegetative coverage within the reclaimed area resulted in >80% of the pre-disturbance levels / reference area. All noxious weeds as defined by the Colorado Department of Agriculture were excluded in calculating vegetative coverage. Interim reclamation as defined by COGCC 1003.e (2) has been achieved. Photographs as required by 1003.e (3) were taken during the growing season and included in this submittal. A copy of the vegetation survey conducted is attached.
