All ground disturbing construction activities at the site have been completed. All pits have been backfilled and compacted and all segregated soil stockpiles have been replaced to their original relative positions and contour and have been adequately tilled in order to establish a proper seedbed. Grass seed with species consistent with the adjacent plant community has been drilled into the seedbed at prescribed rates and wheat straw has been crimped into the seedbed for erosion control. Vegetation on the pad has achieved growth greater than 80% of the background area vegetation count.
