Comments

This is an unplanned sidetrack that occurred while drilling the curve on the Will 6-62-15-0362AH2 (API#05-123-40123) the hang off sub that holds the MWD tool in place became loose and the MWD/mud motor high sides lost alignment. Total measured depth reached in the wellbore being plugged back is 6519'. Casing set – Surface-9 5/8", J55, 36.0# Set @ 805.0' MD. No fish in the hole. Proposed plugs: Bottom of plug will set @ +/-6250' Top +/- 5750 500' 38 bbls of cement. Type of cement to be used for plug: Cement will be Halliburton "Granitecem" 17.5 ppg .94 yield. Measured depth of proposed sidetrack kick-off point is 5800'. Proposed objective formation(s) for sidetrack hole and BHL target remains the same as originally planned.
