We tried to recover sacrificing some azimuth but were in jeopardy of landing in the Carlisle and off target line. Going forward we would like to set a 500' (17.5#) cement plug across the interval from 6650-7150MD. This will allow us to kick off again and retry this curve, we moved KOP up a bit to allow us to focus on azimuth early in the curve.</p> <p>Total MD drilled to: 7430' Surface casing – 9 5/8" 36# set at 871'.
