PIONEER is requesting continued temporarily abandon status on the Lorencito 9-8-34-66 well as it is not feasible to rework the well at this time due to current market conditions. A Form 5A for temporarily abandon status was submitted to the COGCC on 7/28/2015. The Lorencito 9-8-34-66 well is closed to the atmosphere via the wellhead secured and shut-in at the surface as well as a cement retainer at 1100'.
