Comments Caerus Piceance LLC, (Caerus) is refiling the Spruce Creek 8-31D (05-045-18559) which is currently an AL. Caerus is refiling the APD with changes to the well name, SHL, and BHL. The well location plat, deviated drilling plan, and casing and cement program have been updated. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to the proposed Savage 31C-8.
