Nitrogen Frac Blanket

Noble must flare in order to meet pipeline specification, which requires less than 3% nitrogen gas in the gas stream. A flare system will be in place to control the gas stream until pipeline specification has been achieved. Noble's preferred option will be too utilize an enclosed flare; however, if the enclosed flare volume capabilities would be overrun the gas stream will be diverted to an open flare.

The need for flaring is a result of the experimental process that was discussed on Tuesday, July 28, 2015. The project will begin approximately August 13, 2015 with flaring anticipated to begin on or after September 13, 2015.
