Comment: Overall stormwater erosion is satisfactory. Straw wattles have been placed around the perimeter of the location. These need to be maintained in areas and monitored to prevent sediment discharges. Soil stockpiles are setback from the edge of the project area in the southeastern portion of the project area. The project area is located near two irrigation channels and adjacent to wetlands. Therefore stormwater erosion will need to be carefully monitored on this location. See attached photos.
