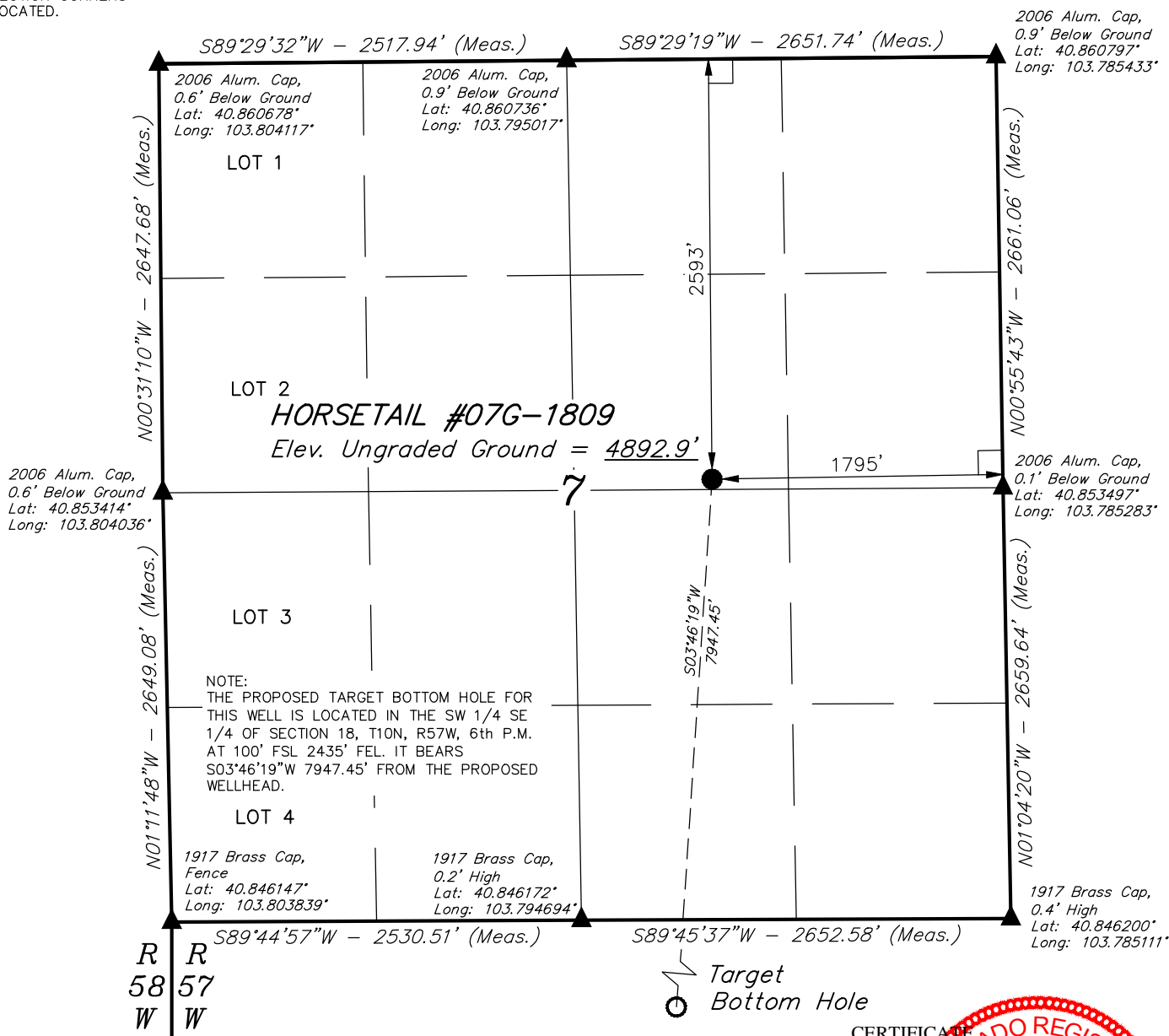

WELL LOCATION PLAT



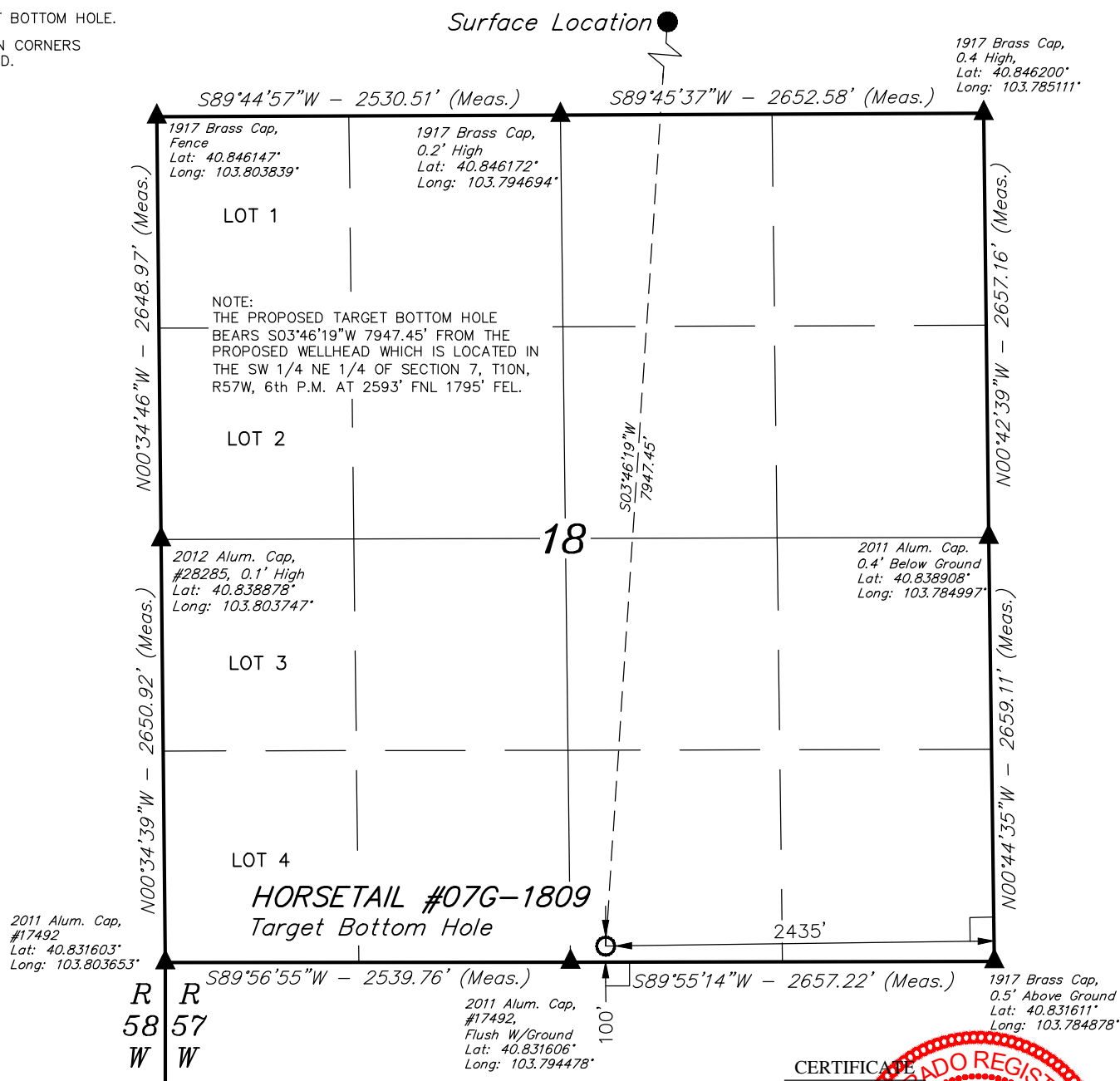

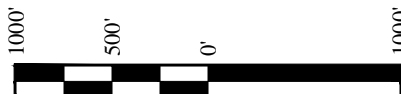
