Reference previously approved Form 4 #400738591 regarding the delay of pitclosure activities during winter months. Pit bottom soil confirmation samples were collected at the site on 9/16/14. Sample locations are depicted on the attached Site Map. Laboratory analytical results indicated compliance with COGCC Table 910-1 with the exception of arsenic concentrations in three of the six samples collected (Table 1). Per the attached email, the COGCC accepts these exceedances and has agreed to close REM #8506 with this submittal of this Form 4. Laboratory analytical reports are attached. The pit (facility ID 436479) was backfilled with clean fill material on 6/22/2015. Seeding of this reclaimed area will be postponed until this Fall to take advantage of seasonal precipitation.
