On behalf of Bill Barrett Corporation (BBC), we have completed the pit closure sampling at the MDP 4 (REM #8506). For your reference, I have attached the approved Form 27 for this project. The samples that were collected from the pit bottom were compliant with COGCC standards or were below background concentrations, and we wish to close the project via a Form 4 as you requested. The email with your request can be reviewed below in this email chain. Due to oncoming winter weather conditions, BBC requests approval to delay backfilling/reclaiming of this pit until the second quarter of 2015. Delaying backfill work until warmer weather conditions are present will ensure that the pit is properly reclaimed. Also, the pit liner has been removed from the site and recycled.
