Attached to this sundry is a revised Exhibit A: Amended Custody Transfer Locations from OXY to PICEANCE ENERGY, a revised "Water Custody Transfer Facility List Rev-2", and three (3) "...Haul Route Maps" that cover the route to transfer production water from a total of 34 Oxy pads to a total of four Piceance Energy pads. Oxy requests no other changes to the agreement package approved on 4/21/2015.
