The North Platte 12-24 well was plugged back @ 6,242' with 2 sacks of cement 8/19/2014. Form 5A to report AB status of Niobrara/Codell was submitted 9/12/2014 (Doc#400686251); the well was SI and PB to offset HZ frac. The well is closed to the atmosphere via valve and the "Temporary SI for HZ Prep" sign is attached to the master valve. We are requesting continued TA status to evaluate future recompletion potential. Well pressure tested 500-700#, held pressure for 15 minutes, test was good.
