This sundry is being submitted to change the cementing/ casing design of this well to a monobore. An oil-based mud system will additionally be used. A sundry for the Downtown location (ID# 432599) has been submitted for the Waste Management Plan to reflect this shift from a water-based mud system. An offsite commercial disposal plan was already in place.

Our cementing/ casing plan does provide coverage for the Upper Pierre Aquifer as the long string of this well will be cased to surface and cemented up into the surface casing.

A new deviated drilling plan is attached because we wanted to ensure adequate aquifer coverage and, with the new monobore designed, wanted the well to remain more vertical down to the surface casing shoe.
