Comments

The 5 proposed new wells will produce to the State North Platte CPF 42-26 Facility (434730), as noted in the related remote locations tab. The two existing wells will remain on production to the onsite facilities. However, if economic conditions warrant the reduction of wells and or well pads in the area, there is a possibility that the CPF will not be constructed, and the production facilities will need to be built on this pad. Therefore, we have included all facility equipment for that case in the "Facilities" section of this permit. It is not the intention of Bonanza Creek to build the full amount of permitted equipment on all locations, rather it is the desire to minimize disturbance and optimize our operations to ensure excellent stewardship that we are requesting this flexibility. The final equipment listing for this location will be reported to the COGCC on a sundry to accurately reflect as-built conditions at the time interim reclamation is completed.

Nearest water well is 23003-MH.

The MLVT to be deployed on Location is Manufactured by JCR Fabrication and leased by Hydrologistics. Each tank will be erected with a new liner. Each tank is 42,000 bbls. Tank will be on location October 1, 2015 - September 30, 2016.

1	Construction	The following procedure describes BCEL standard construction practices for setting a partially buried pre-cast cement water vault and new tank battery construction. 1) The excavation will first be lined with 4" of clay or other low permeability soil. 2) A 30 mil liner will be installed on top of the low permeability soil. The 30 mil liner will be a contiguous liner which will underlay the entire tank battery. 3) The tank battery / water vault liner will be keyed into a galvanized steel containment ring installed surrounding the tank battery. 4) Sand bedding will be installed to protect the synthetic liner prior to placing equipment in the containment area.
