This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the RMV 205-20 well pad in accordance with footnote 1 to the COGCC table 910-1. The request is based on the analytical results presented below (see attached laboratory reports).  
 One composite sample was collected from the cuttings management area to determine the arsenic concentration in the cuttings.  
 RMV 205-20 cuttings – 12 mg/kg  
 Three grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.  
 RMV 205-20-B-1 – 15 mg/kg  
 RMV 205-20-B-2 – 18 mg/kg  
 RMV 205-20-B-3 – 15 mg/kg  
 RMV 205-20-B-4 – 17 mg/kg  
 RMV 205-20-B-5 - 12 mg/kg
