Ms. Archuleta and Ms. Blanchard,

Our records indicate that Samson Resources has two active wells (067-08993 and 067-09111) and Elm Ridge Exploration has one plugged and abandoned well (067-08919) on the 311926 location. Elm Ridge has recently conducted interim reclamation activities such as reclamation of a pit, seeding, weed control, and stormwater control on the location. As Elm Ridge no longer supports any active wells on the location it appears that a Form 10, documenting transfer of operator is needed for the location. If this is the case, please provide this documentation to the COGCC to assure that reclamation responsibilities are properly coordinated.
