1. Hold a pre-job safety meeting. Discuss all aspects of the procedure with any involved personnel. Identify and address any safety concerns before the job begins.
2. MIRU pulling unit. Kill well with produced water.
3. ND wellhead, NU BOP.
4. Un-land Tubing.
5. POOH with tubing.
6. RU wireline.
7. RIH and set RBP @ 8050' and pressure test plug to 500 psi. Dump 1 sx sand on top of plug.
8. Un-land 4-1/2" production casing.
9. NU annular fill wellhead.
10. RIH down 4-1/2" by 8-5/8" annulus with 1-1/4" tubing to 5000'.
11. Establish circulation and pump 50 sx of class G cement from ~5000' to 4800'.
12. PU tubing to 4800'. Establish circulation and pump 50 sx of class G cement from ~4800' to 4600'.
13. PU tubing to 4600'. Establish circulation and pump 50 sx of Class G cement from ~4600' to 4400'.
14. PU tubing to 1800'.
15. Establish circulation and pump 400 sx of class G neat cement, taking returns up annulus to surface.
16. Ensure that all cementing work complies with COGCC rule 317j (listed on previous page).
17. POOH and lay down 1-1/4" tubing.
18. Re-land 4-1/2" casing and load hole with water.
19. RU wireline.
20. Run CBL and log from RBP' to surface.
21. RD E-line.
22. RIH with tubing, circulate and pull RBP.
23. Hydro test tubing.
24. RIH and land 2-3/8" @ 8105'.
25. ND BOP, NU 5K wellhead.
26. Replace tubing master valve.
27. Swab well back in.
28. RDMO Workover rig.
