Comments:

This Form 4 is being submitted in follow-up to a discussion with COGCC staff regarding Inspection Document #680100061. Within this inspection it requests that control efforts on Jointed goat grass be completed by 08/18/2015. In reviewing control efforts of this species with the Garfield County Vegetation Manager per COGCC requirements the application of herbicides for treatment will not be completed until later this fall. It is currently expected that control efforts will occur between September 1 and October 31. Annual site conditions and species conditions will be monitored so that application is timed appropriately within this time frame. Once control efforts have been applied a Form 42 will be prepared and submitted to the COGCC for corrective action tracking. The site will then continue to be monitored for this species and follow up efforts for vegetation establishment will occur later in the fall of 2015.
