An open hole sidetrack will be initiated at 7,365' MD. The operation will begin by trougning the existing wellbore, and then time drilling with a controlled slide. The sidetrack well plan has us low siding to the right of the existing wellbore until we gain approx 1.5' of separation. At that time we will roll the assembly back and track towards the original well plan.

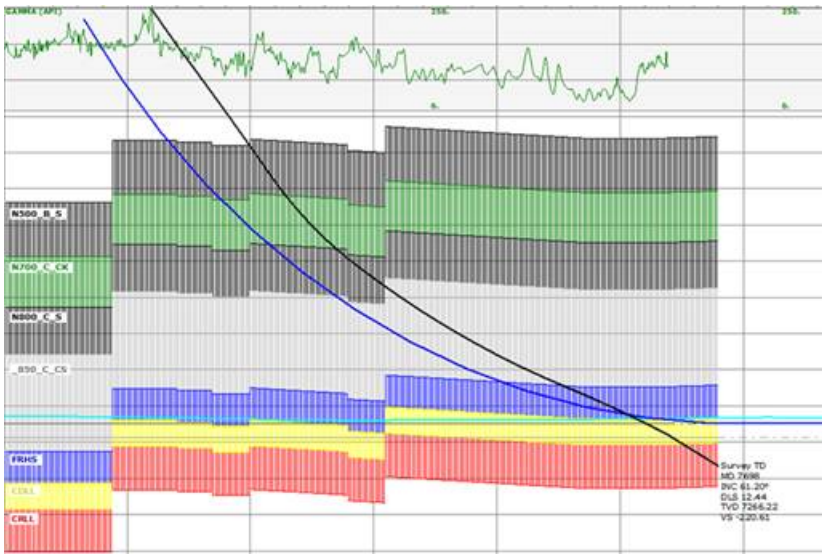

- [A suspected MWD malfunction caused us to deviate from the line while drilling the curve section. The directional driller initiated a slide at 7556' MD to build inclination, and the assembly did the opposite by dropping downwards. This put us in the Carlile formation. See correlation below \(black curve\):](#)
