COMMENTS:

Bill Barret Corporation (BBC) is submitting this sundry to request an extension to the interim reclamation due date of 8/31/15. This well was completed in January 2014. BBC filed for and received COGCC approval to extend the interim reclamation due date from July 2014 to August of 2015 given plans to re-occupy the pad and drill 5 additional wells (API #'s of approved permits: 123-41039, 123-41040, 123-41042, 123-41041, 123-41064). At the time the sundry was filed to seek the initial extension, BBC had three rigs actively drilling in the area. In January of 2015, BBC released two of the three rigs running because of the sudden drop in commodity prices. BBC has since contracted an additional drilling rig and drilling is scheduled to commence on the first of 5 wells in April of 2016, lasting into late June of 2016. Prior to the drilling rig moving in, a surface rig would pre-set surface casing, likely starting in March. Conducting interim reclaim efforts now would not prove beneficial, there would be no established vegetative cover by the time the pad is re-occupied and volume/viability of the topsoil would be damaged.

BBC is attaching a detailed stabilization plan, diagram and seed mix that would be implemented within 30 days of approval of this sundry. BBC would commence interim reclamation activities within 60 days of conclusion of completion operations in 2016. In the event drilling operations were further delayed in 2016, BBC would proceed ahead with interim reclamation, ensuring activities were completed in 2016.
