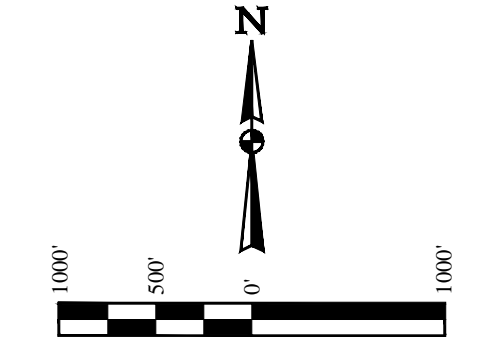


- LEGEND:
