E/2E/2 Sec. 21-T5N-R61W 6th PM, Weld County, CO – containing 160 Acres more or less

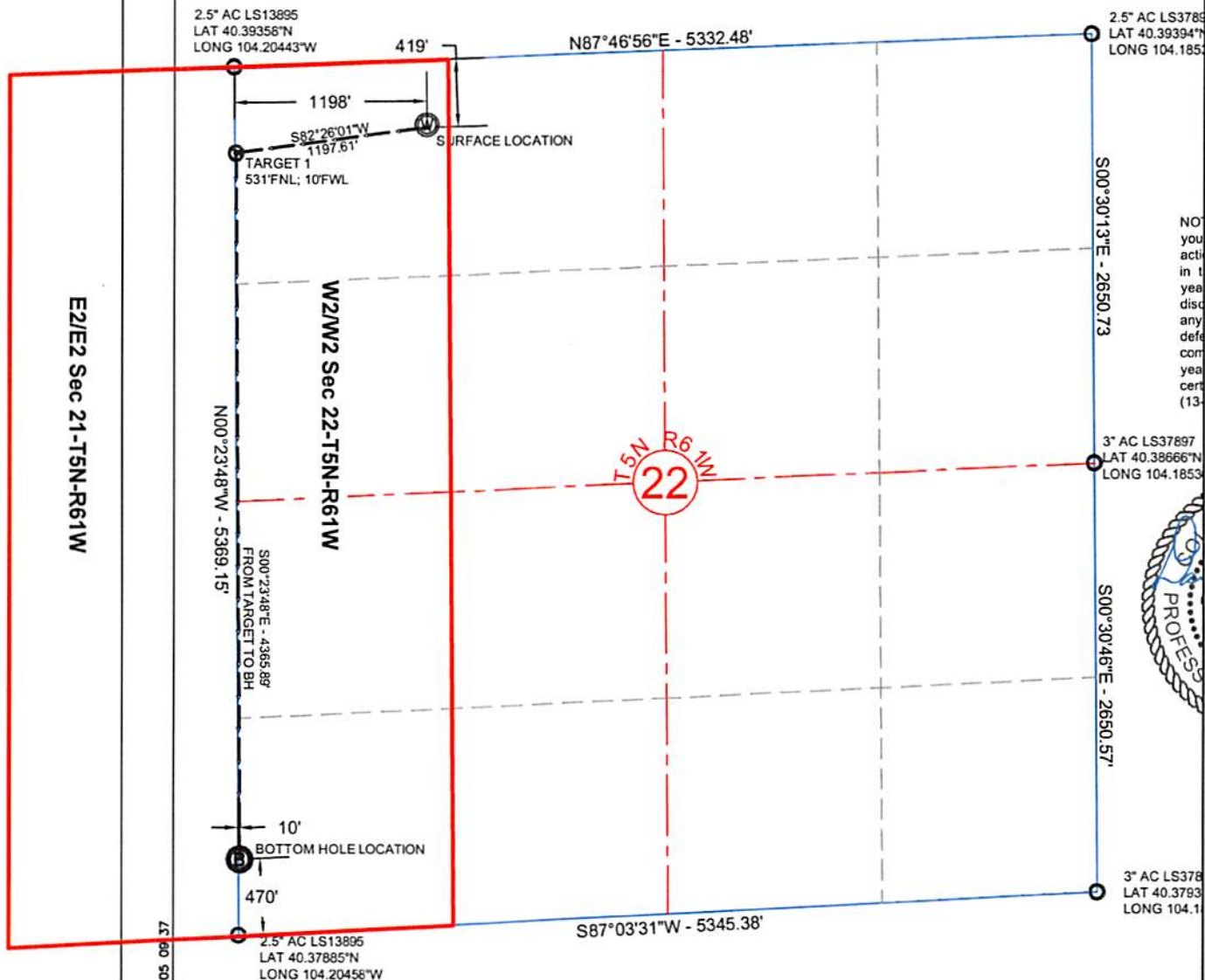
Bonanza has notified the other owners in the unit and no objections were received. Copies of the notifications are maintained in Bonanza's files.
