1) In the Water Resources section you have indicated that the estimated depth to groundwater is 200 feet based on the nearest water well (Permit #17026-F). A review of that water well permit indicates that 200 feet is the total depth of the well, but no static water level was listed. The next nearest water well is the Lloyd Lambertson well (Permit #271318) with a listed static water level of 40 feet. Therefore, I would like to change the estimated depth to groundwater to 40 feet on the Form 2A.
