COMMENTS:

Completions was in the process of flowing back the Taipan 27C-15HZ when the surface casing pressure spike occurred. We believe this spike was due to the flowback fluid coming to surface was at a high temperature which led to the thermal expansion behind the surface casing and a buildup of pressure. The pressure came up to 345 psi and it was bled down. Over the next 15 hours pressure came up to 300-400 psi several times and each time it was bled down. After that time period the pressure remained at 0 psi and no further action was taken.
