The well reached total depth of 7,900 feet instead of the permitted depth of 7,850 feet. This was due to some uncertainty in formation tops which PetroShare anticipated may be running a little low. There was additional need for more rat hole to allow for some fill and still accommodate stacked logging tools. The well TD'd in the Carlisle formation which was on the original permit.
