908 WQ test update. On 4/2/15, Cottonwood Consulting was again unable to obtain a sample from the WQ 11-90-27 #2 test site in order to complete the 908 testing. An attempt was made to collect a sample on 12/4/14 but due to frozen conditions, it was unsuccessful. On 4/2/15, the outflow valve at Ault Reservoir (WQ 11-90-27 #2) was closed and locked. A new attempt will be made in May/June.
