Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the E/2E/2 Sec 7, W/2W/2 Sec 8, NW/4NW/4 Sec 17, NE/4NE/4 Sec 18, T3N, R63W, creating a 400-acre wellbore spacing unit for the Niobrara formation.
