For our Aggie State AA17-628, the Fair Meadows 1-30 (API# 05-123-12861) is listed as an off-set well operated by Bayswater. Noble would like to request an Off-set Option #4: Pull tubing, install at least 1 RBP, pressure test of casing to a minimum of 3000 psi, install a 5K wellhead, and monitor of the Bradenhead during hydraulic stimulation". Bayswater has submitted a Drilling completion report (form 5) to document the cement that is present in the hole that was originally there and then the casing repair that took place in 2007.
