Well drilled to surface casing depth ~3,300' - no penetration into the producing zones, no perforations or ability for the well to make gas. Well has abandonment cap with pressure integrity on the surface casing. The casing heads have pressure bleed-off capability through a ball valve on the braden head port. Encana intends to drill and complete this well in the future.
