I have reviewed the referenced Amended Form 2A Oil & Gas Location Assessment and have the following comment.

- 1) In the Facilities section you have indicated there will be no separators on this amended oil and gas location. However, your Facility Layout Drawing (Interim Reclamation Plan Figure #4) depicts three separators. Please confirm the number of separators.
- 2) In the Cultural Distances section you have indicated the nearest Public Road, Above Ground Utility, and Property Line from an oil and gas well is 664 feet, 644 feet, and 671 feet, respectively. However, a review of your Location Drawing indicates these three distances are from the the proposed new wells while the existing Critter Creek 9-15H well is approximately 150 feet closer to these three cultural features. Therefore, please provide me with revised distances to these three cultural features from the existing well.
- 3) In the Water Resources section you have indicated that the estimated depth to groundwater is 440 feet based on the nearest water well (Permit #271318). A review of that water well permit indicates that 440 feet is the total depth of the well and the static water level is 40 feet. Therefore, I would like to change the estimated depth to groundwater to 40 feet.
