I have reviewed the referenced Amended Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Cultural Distances section you have indicated the nearest Building and Building Unit from both an oil and gas well and production facility is 5280 feet (greater than a mile). The original Form 2A for this oil and gas location indicates the nearest Building is 3,562 feet away. During my review I identified this Building to be a house (Building Unit) to the southwest. Therefore it appears the nearest Building and Building Unit to an oil and gas well is 3,562 feet. Please provide me with the distance to this house from the nearest proposed production facility and I will revise this in the Cultural Distance section of the 2A.

2) In the Water Resources section you have indicated that the estimated depth to groundwater is 35 feet based on the nearest water well (Permit #33975-). A review of that water well permit indicates that 35 feet is the total depth of the well and the static water level is 22 feet. This is also the depth to groundwater listed on the original Form 2A for this oil and gas location. Therefore, I would like to change the estimated depth to groundwater to 22 feet.
