Noble must flare in order to meet pipeline specifications, which requires less than 3% nitrogen gas to be present in the gas stream. A flare system will be in place to control the gas stream until pipeline specifications have been achieved. Noble's preferred option is to utilize an enclosed flare; however, if the enclosed flare volume capabilities would be overrun, the gas stream will be diverted to an open flare.

The need for flaring is a result of the experimental process that was discussed on Tuesday, July 28, 2015. Flaring is anticipated to being the week of September 21, 2015.
