Mickenzie,

I have completed my review of the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Construction section you have indicated the size of the location after interim reclamation is 4.75 acres. However, a review of your Facility Layout Drawing (Interim Reclamation Plan Figure #4) indicates that 4.754 acres is the total acreage of the pad of which 3.132 acres will be reclaimed, leaving 1.622 acres after reclamation. Therefore, I would like to change the size of the location after interim reclamation from 4.75 acres to 1.62 acres.

2) You have indicated that this proposed oil and gas location is within a Floodplain. Therefore, I will place the following Condition of Approval of the Form 2A:

*"This oil and gas location is in a Floodplain; therefore, Operator shall comply with all requirements of COGCC Rule 603.h. including, but not limited to, remote shut-in capabilities of the wells, secondary containment around tanks constructed with a synthetic or geosynthetic liner that is mechanically connected to a steel ring or another engineered technology that provides equivalent protection from floodwaters and debris, and ground anchoring of all tanks and separation equipment."*


