Mr. Hixon,

I spoke with Denise Arthur about your request regarding woody debris on the 067-08295 location. She indicated that we can allow the surface owner to continue to use a portion of the interim reclamation area for woodcutting. However, it is our expectation that you will communicate with the surface owner that the disturbance should not get bigger than it currently is with one or two small woodpiles somewhat neatly stacked. In addition, we recommend that the vegetation that was disturbed by the wood cutting, shown in Photo 1 of inspection number 680600085 be re-seeded and new disturbance to this area kept to a minimum.

I will have this correspondence uploaded to the well file for this location to document that the current condition of wood piles are "Satisfactory" and XTO is in compliance with the required actions outlined in the 680600085 inspection pertaining to removal of junk and debris from the location. As we discussed, XTO will still need to comply with the corrective action to repair stormwater erosion along the access road at the location.
