COMMENTS:

Five soil borings were drilled on 06-02-2015 to delineate the extent of the contamination (map attached) and PID readings were collected in order to field screen the samples and decide which samples were to be sent to a laboratory for TPH (GRO, DRO, ORO) analysis. The laboratory analysis is attached. No BTEX compounds were found in any of the samples. The only sample with TPH (GRO, DRO, ORO) exceeding 50 mg/kg was from boring V1 at a depth of 6 feet. This boring was completed near the leak (see attached map). The sample collected from a depth of 10 feet from V1 has a TPH concentration of about 15 mg/kg (GRO). The only other sample that contained TPH (GRO) was the sample collected from boring V3 which is to the east of the boring. It appears that the contamination is along the road/pipe line and is about 50 feet long and 20 feet wide. Groundwater was not encountered during the drilling operations.

Excavation will begin on Tuesday, June 16, 2015 at the request of the surface owner and will follow the area delineated with the soil borings. Once the excavation is complete, the flowline will be repaired and tested following rules 1100. Soil samples from the excavation will be analyzed for TPH (GRO, DRO, ORO) to verify that all contaminated soil has been removed.
