XTO Energy respectfully requests an exception to Rule 317.p, due to unforeseen events encountered during drilling operations described in the attached letter. We encountered full lost circulation at various depths (6,500', 10,000') and the variable hole size would also lead to some risk. As a result, the TD will be shortened to +/- 12,600' (proposed 13,614'). In lieu of the required open-hole logs, XTO proposes to run a CBL w/gamma ray on the production casing into the surface casing and then run a cased-hole pulsed neutron/gamma ray log from TD into the surface casing.
