#### COMMENTS:

Chevron is seeking Continued Temporarily Abandoned Status for the subject well and is providing this description of future plans for utilization of the well per COGCC request (email dated 07/28/2015). Chevron's current intentions are to complete SKR-598-36-BV-12 well in June 2019. Current gas prices do not allow for an economic completion. Added costs of fully abandoning the wellbores and then re-entry to complete the wells in 2019 would worsen the economics and delay completions beyond 2019. The wellbore is cased and CBL's have been run proving good cement. Last MIT was on 05/28/2015 and met the requirements for well integrity. No production equipment has yet been installed.
