Need to adjust the BHL to stay under Section 29 to abide by Easement agreement. Well was spud yesterday 9-30-15. This is approximately an 80' shortening to the directional reach before going vertical to BHL. No changes to Formations, Casing & Cement, or BMP's. This change does not affect any of the Notifications sent. Evidently the original MD's and Formation tops permitted were incorrectly input using the TVD's. Attached is a Corrected WB Diagram (Planned) showing the corrected Formation Tops and Casing & cement and TD (MD). I Consulted with Bob Koehler this AM about this issue and he agreed a Sundry should be OK to correct all.
