THE EXISTING 2A ALLOWS FOR 1 DRILLING PIT TO BE UTILIZED AS A CUTTINGS TRENCH TO STORE SURFACE HOLE CUTTINGS. BBC PLANS ON ADDING AN ADDITIONAL DRILLING PIT TO BE UTILIZED FOR COMPLETION PURPOSES FOR THE WELLS LOCATED ON THIS PAD. AN UPDATED PLAT SHOWING THE LOCATION OF THE 400'X45'X15' (40,585 BBL) DRILLING PIT IS ATTACHED. BBC WOULD ALSO LIKE TO ADD 30 500 BBLS FRAC TANKS TO THE EXISTING 2A FOR COMPLETION OPERATIONS.
