Subject: U.S. Department of Energy Office of Legacy Management Preliminary's Review of Well Permit Applications and Well Location Information near the Rulison, Colorado, Site

Dear Ms. Freeman:

The U.S. Department of Energy Office of Legacy Management (DOE-LM) has performed a preliminary review of (1) the well permit applications from the operator Caerus Oil and Gas, LLC and (2) the well location information provided by the Colorado Oil and Gas Conservation Commission (COGCC). The table below indicates the planned surface and bottom hole locations for gas wells to be drilled near the Rulison, Colorado, site. DOE-LM reviewed the location information and determined that all of the wells are within section 2 of the COGCC Tier II sampling area.
