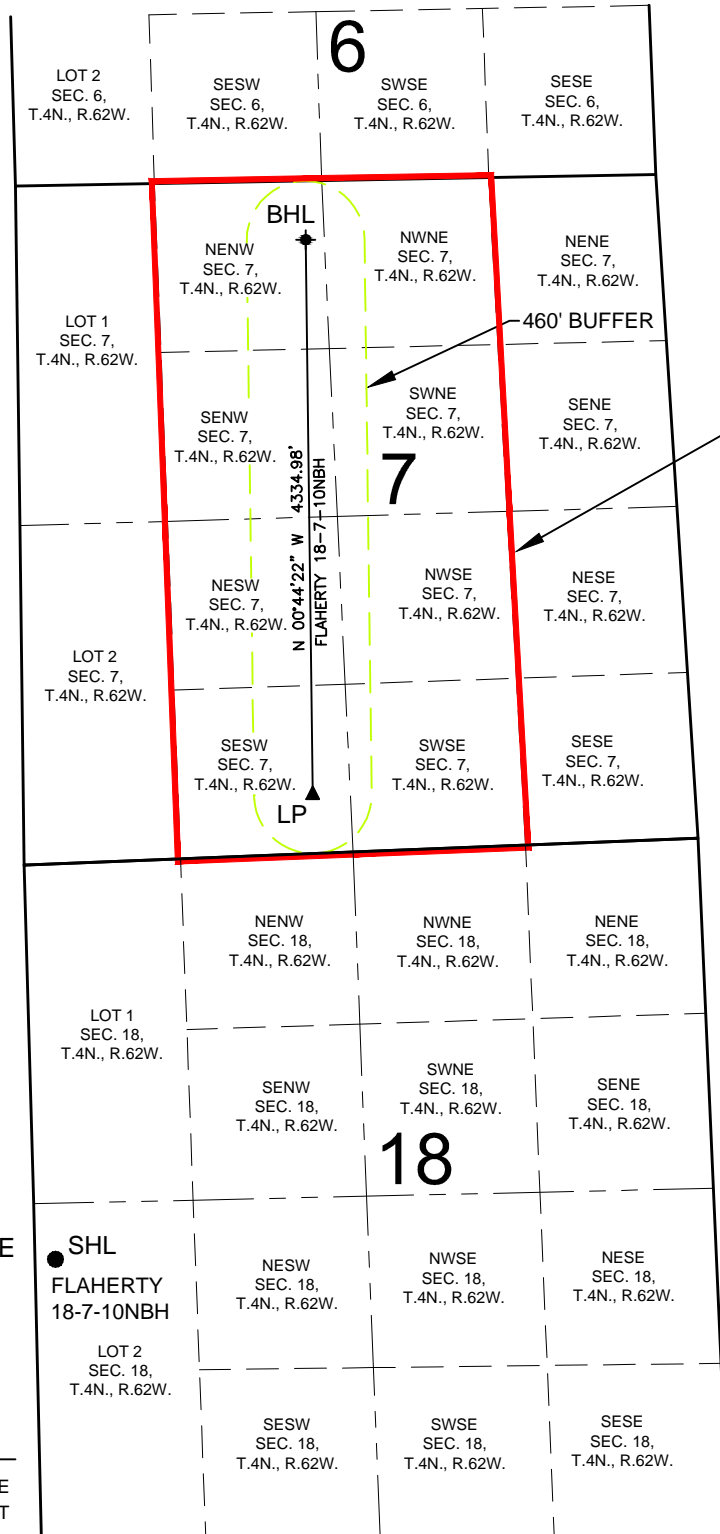

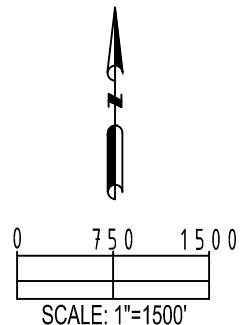
**FLAHERTY 18-I PAD**
